


**ACKNOWLEDGEMENT TO BE SIGNED BY SECURITY COMMUNITY OR ANY

OFFICIAL GOVERNMENT RESIDENCE IN RESPECT OF THE OFFICIAL
SECRETS ACT 1972 [ACT 88]**

I hereby acknowledge that my attention has been brought to the provisions of the Official Secrets Act 1972 [Act 88] and that I fully understand the meaning of the Act. Specifically, I understand that wrongfully conveying, using or keeping and not taking care in the appropriate manner an official secret and official correspondence or any conduct that endangers the security or secrecy of an official secret is an offence under Section 8 of the said Act which, upon conviction, may be punishable with imprisonment of not less than one year but not more than seven years.

I understand that all official secrets and official correspondence that I acquire in the service of the Seri Paduka Baginda Yang di-Pertuan Agong or the service of any Government in Malaysia are the property of the Government and I will not leak, publish or convey the same, whether orally or in writing or by electronic means to any other person whatsoever in any form, whether during or after my service to the Seri Paduka Baginda Yang di-Pertuan Agong or to any Government in Malaysia without obtaining the prior consent in writing from the relevant authority. I promise and acknowledge that I will sign a further declaration for this purpose upon completion of my dealings with the service of the Seri Paduka Baginda Yang di-Pertuan Agong or service of any Government of Malaysia.
